1. One-and two-family dwellings when the total building heating/cooling system input rating is 375,000 Btu's or less.
2. Alterations and repair work determined by the mechanical official to be of a minor nature.
3. Business, mercantile, and storage buildings having HVAC equipment only, with one fire area and not more than 3,500 sf.
4. Work completed by a governmental subdivision or state agency costing less than \$15,000.00.

If work is being performed is described above, check box below "Plans Not Required."

Plans are required for all other building types and shall be prepared by or under the direct supervision of an architect or engineer licensed pursuant to 1980 PA 299 and shall bear that architect's or engineer's seal and signature.

GENERAL: Mechanical work shall not be started until the application for permit has been filed. All installations shall be in conformance with the Mechanical Code. No work shall be concealed until it has been inspected. When ready for an inspection, call 24 hours in advance. The inspector will need the job location and permit number. A permit shall remain valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if work is not commenced within 6 months after issuance, or if work is suspended or abandoned for a period of 6 months. Cancelled permits cannot be reinstated or refunded. **Minimum permit fee \$75. (effective 7/1/14)**
